



DECLARATION OF COMPLIANCE for all plastic components in contact of food

We hereby confirm that all plastic components in contact of food of the following products

COMANDANTE (MKIII) C40 NITRO BLADE
COMANDANTE (MKIII) C40 IRONHEART

comply with the legal regulations laid down in the european plastic regulation (EU) Nr. 10/2011 as well in regulation (EU) Nr.1935/2004, both as amended.

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The testing was performed according to regulation (EU) Nr. 10/2011.

The materials and raw materials used comply with plastic regulation (EU) Nr. 10/2011. The following substances subject to limitations and/or specification are used in the above mentioned product:

Note on dual use substances:

Substances also approved as food additives do not migrate or are contained in marginal quantities only so that they do not display any technological effect in case of migration.

Specification of the intended use or restrictions:

- Types of food or processes for which the material is suitable:
Coffee, tea, herbs, grain
- Type of food or processes for which the material is not suitable:
alcoholic foodstuffs
